MINUTES

Minutes of the regular meeting of June 6, 2019 were approved with a motion by John Petrides seconded by Scott Lenz, unanimously carried.

Stephanie Gould introduced herself as our new Council Liason.

NEW BUSINESS

- A. Summer Programs update – Ozoroski provided a list of summer programs and noted how busy the staff was and how he was extremely happy with how hard everyone worked.
- B. Golf and Pool Comparisons and updates – Ozoroski handed out the golf and pool comparison. Pool memberships and revenue were up from last year while golf is a little bit down in both memberships and revenue.
- C. Letter regarding Senior Pool Membership – The Board discussed the letter from the Gallo's regarding out-of-town senior membership rates at the Pool. The Board voted unanimously to add another out-of-town category that doubled the price of the Summit Senior to \$140.00.

OLD BUSINESS

- A. Memorial & Tatlock Tennis Courts – Ozoroski said Memorial Tennis courts were patched in spots and repainted in late July/early August. Summit High School Tennis and the STA are extremely happy. Tatlock Tennis court fencing received new paint due to cracking and peeling from the original paint.
- B. Sunscreen dispensers – Ozoroski said nobody from the Enright pursued the Sunscreen dispensers, so at this point it is a done deal.
- C. Transfer Station – No meeting.
- D. DCP Vacancies – Ozoroski told the Board that the new Program Aide, Nolister Montas will be working fulltime in mid-September. Ozoroski also advised that he will start working on Joanne's replacement.
- E. Naming Youth Lounge – The naming of the Jordan Glatt Youth Lounge will be on the Council agenda for Wednesday, October 2nd.
- F. Glenside Field Update – Ozoroski stated he is having a meeting with Union County to talk about scheduling and the agreement the City has with Union County regarding Glenside.
- G. Community Center Update – Building is getting close to being complete but still working on a punch list.
- H. Playgrounds Update – Ozoroski told the Board that 20 new swings were placed throughout the City's playgrounds and that he is going to slow down the replacement of the playground until he gets a better idea of what is needed. David Guida is taking a course to become a Certified Playground Inspector. Once that is completed, he will audit all of the playgrounds to determine what is needed.

- I. Pat Darcy Anderson Field House – Nothing to report. Ozoroski will talk to the City Administrator to see what the next steps are.
